Notes for Applicants:

1. Members are elected at a full committee meeting or in special circumstances, by an interim membership committee.
2. Each completed application is displayed on the Club noticeboard for at least 14 days prior to confirmation of membership.
3. A copy of the Memorandum, Articles of Association & Rules is available in the Clubhouse.
4. Membership of the Club and acceptance of the Rules by the Member are deemed to constitute consent to the holding by the Club of relevant personal data for the purposes of the Data Protection Act 1998.
5. BSC members take photographs (which may include you and your family) for the purpose of display on the BSC website, on social media, in the BSC year book and for other publicity purposes.
6. There may be a waiting list for cruiser moorings or storage.
7. Applicants with cruisers who intend to lay-up at the club will require suitable trolleys.
8. Maximum size for a cruiser is 5 tons gross including trailer and 30' LOA.
9. The charge for a cruiser includes a mooring position (but not tackle), storage in the open, hauling in & out, use of the mast crane & high pressure washer plus a pulling dinghy kept ashore as a tender.
10. Members are responsible for their own mooring tackle. If after inspection, the mooring tackle is found to be unfit for use, the Club will require remedial work to be done before the mooring can be used.
11. At all times it is for members to decide whether their craft, equipment and crew are fit to sail in the prevailing conditions.
12. **Third party insurance in the sum of at least £2 million is mandatory for all craft..**
