Notes for Applicants:

1. Members are elected at a full committee meeting or in special circumstances, by an interim membership committee.
2. Each completed application is displayed on the Club noticeboard for at least 14 days prior to confirmation of membership.
3. A copy of the Memorandum, Articles of Association & Rules is available in the Clubhouse.
4. Membership of the Club and acceptance of the Rules by the Member are deemed to constitute consent to the holding by the Club of relevant personal data for the purposes of the Data Protection Act 1998.
5. BSC members take photographs (which may include you and your family) for the purpose of display on the BSC website, on social media, in the BSC year book and for other publicity purposes.
6. At all times it is for Parents of Cadet members to decide whether their craft, equipment and crew are fit to sail in the prevailing conditions.
7. **Third party insurance in the sum of at least £2 million is mandatory for all craft.**

Parent or Guardian's Consent and Certificate

N.B. Parents and Guardians are warned that the Club is able to provide safety (rescue) facilities only during the hours of Club racing. Parents and guardians retain sole responsibility for their children and wards at all times. Cadets are required to wear life jackets or buoyancy aids at all times whilst on or near the water.

to take part in water based and other activities at the Club and accept responsibility for his/her behaviour and adherence to Club Rules and standards.

It is understood that reasonable instructions of Club Officers and Members are to be obeyed and also that the Club is able to provide safety facilities **only during the hours of Club racing.**
